



2021 Waiver & Requirements

Thank you for joining Determined Events! We understand that the valley provides several options for small businesses like yours to participate in & we want to thank you for your support & your participation in our event & our community. We work hard to promote a fun & professional environment for not only you as supported small businesses but for our guests & community as well. We expect you to positively contribute to creating a fun safe event to grow your brand. Signing & submitting this agreement you agree to adhere to the following best practices and values.

Events Requirements

Food Trucks, Trailers & Carts:

- Must have your own power source. (i.e: a generator). No electricity will be provided.
- The Following is required to be submitted with this waiver/application in order to participate: Business License, TPT with the City of Avondale included, Proof of Insurance with the City of Avondale as additionally insured. Up to date Health Department Permit, Logos, pictures of your truck/trailer or booth & pictures of your products.
 - Required to complete registration form via GetDetermined.net
- Agrees to pay all fees for any & all cancellations (\$100 fee) & 'no shows' (\$200 fee) to within 24 hours of said cancellation or "no show".
- Required to maintain a sales report for all Events & submit this report at the end of each event for the required 10% sales commission paid out to after each event in cash on site.
- Must arrive according to the time specified in your pre-event email transcriptions. Arrival times for each event are delivered via email within 24 hours of the event's start time containing all necessary directions, maps, as well as all other pertinent information required for your participation.
- Arriving late may result in a 'cancellation' or 'no show' where the responsible party would then be accountable for the associated fees - due immediately.
- Must only submit photos & information of their own food items & may not at any time submit plagiarized pictures or information & claim it as their own for the sake of marketing & promotions.

Pop Up Vendors:

- Must have a 10x10 canopy tent for every event. Tent must not have any tears, or be broken in a way that may create any sort of liability &/or pose a risk to others. Tent must also have 20lbs of weights (5lbs each leg) in the case of inclement weather.
 - Required to have lighting for evening events (battery/solar - no electricity provided)
 - Must pay the mandatory space fee w/in 48 HOURS of accepting the event.
 - Required to register as a new vendor through GetDetermined.net
- All paperwork your business requires - we require you send in one email to getdeterminedinfo@gmail.com.

Payments & Commissions

Food Trucks, Trailers, Carts & Pop-Ups

- Required to maintain & submit a sales report for all events.
- Agrees to pay 10% commission of **GROSS SALES** (reason for the sales report) for each event.
- Determined Events reserves the right to change this percentage at any time for any reason.

Pop-Up (Non-Food) Vendors

- Must pay a \$25 Space Fee for each event due w/in 48 HOURS of the accepting the event, no later. This fee secures your spot for the event.
 - This fee is non-refundable within 48 hours of the event date.
 - No sales commission is collected for pop-up vendors at any of our events at this time.
- Determined Events reserves the right to change these fees & payments structures at any time for any reason.

Liability Release & Nondisclosure Agreement
